The vaccines for the Centre will be supplied by the Government of India through CRI Kasauli on a reimbursement basis. As per the present norms, the cost of one dose of Yellow Fever Vaccine chargeable to each vaccine is only Rs. 300/-. You are requested to intimate this Directorate, regarding the address, contact details, day and time of the vaccination days for information update on website. A login ID and password will be provided to the Nodal officer to upload the monthly report on the CIHD website.
